MINUTES FOR THE MEETING OF OCTOBER 20, 2006

The meeting was called to order at 7:35 p.m. by acting president Jeep Iacobucci, as regular president Regis Schilling was either (a) in jail again, (b) drunk, (c) out of the country, (d) all of the above, or (e) none of the above. Close your eyes and pick one—my students do it all the time!

The meeting began with a presentation by Sandy Ray, who is a fire safety official with the Stow fire department. Sandy provided an very interesting and well-done program on how to avoid household fires and what to do and not do if one occurs. For example, if a fire breaks out in a pan on the stove, do not try to move the pan—you will provide extra oxygen to the fire and cause it to flare up. Do not try to put out a grease fire with water, as it will only spread the fire and make things worse. If possible, just cover the pan with a lid and let the fire put itself out due to lack of oxygen. If you must use a fire extinguisher, stand back six to eight feet from the fire when you activate the fire extinguisher because the contents of the fire extinguisher are under considerable pressure and if you are too close you will blast the fire out of the pan and spread it throughout the area.

Sandy mentioned a number of obvious things that we all know, but she emphasized that it doesn't hurt to be reminded of them. Never leave a burning candle unattended, for example. Never plug more than three strings of Christmas lights together. Don't smoke while you are drinking gasoline. (Actually, she didn't say that. I just made it up.)

We should be sure to check the fire extinguishers in our old cars every now and then to make sure they are still in working order. Most of these fire extinguishers are the dry powder type and one way to check them is to hold the extinguisher horizontally with one hand on each end. Tip one end up and notice whether or not the end that is lower gets heavier. If it doesn't, chances are the powder has caked up inside the extinguisher and it is time to replace it. Another thing to notice is whether or not you can hear the powder moving around inside when you shake the extinguisher. If not, buy a new Class B extinguisher, which is meant for flammable liquid fires such as gasoline and oil. Member Yahdah Nobedder asked if a good way to test a fire extinguisher was to stick it in your ear and pull the trigger. Sandy said no.

She also pointed out that smoking is the number one cause of fire deaths that occur at home. Families should have a fire evacuation plan worked out and should have a meeting place outside the home in case they do have to evacuate. This is especially important for families that live in apartment buildings. If everyone gathers at an agreed-upon place, it is easy to be sure everyone is out of the house. Change smoke detector batteries every time you change your clocks for daylight savings time. Never turn on the laundry dryer and then leave the house. Be sure to clean lint from underneath the dryer on a regular basis, as this lint get sucked into the dryer and can start a fire. If you have a fireplace, the chimney should be cleaned once a year. If you do get burned, the best thing to put on it is just water.

Many thanks to Sandy. Her presentation was excellent!!

Treasurer Ann Davis reported on our financial condition. We still have one. Thanks to the Swigarts for the coffee and cookies for tonight's meeting. Congratulations and thanks to Truman and to Foster for their efforts on our club tour. Thanks also to Sonny Hunt and to Joe and Ann for the wonderful outing at the Hunt residence. The collection of cars that showed up was astounding, and the fish fry and accompanying food was delicious.

Membership chairperson Dick Deyling reported that 29 members have paid dues for 2007 so far. If you haven't sent your check in, please do so immediately or sooner. Sunshine chairperson Ruthie Canankamp reminded us that she still has the small club patches available for \$2.50 each. She also informed us that Barb Rooney's father has been having some health problems and is currently undergoing rehabilitation in a nursing home. We wish him well.

Bill Cassidy has three of the club's license plate toppers left. See him if you want one. SEMA representative Pat Rooney reported that antique car fans have a supporter in Ohio state representative Kenny Yuko, who is actively working to support legislation favorable to the old car hobby.

Ann Davis reported that progress is being made on the 1939 dash that the club is restoring to donate to the Ford Foundation Museum. Joe sandblasted it and welded up the extra holes, and Ann has already made arrangements to have it woodgrained.

National director Craig Gorris announced that the national director's teleconference meeting is scheduled to tomorrow. He will give us a report on what happened at our next meeting.

Barb Soltis announced that the joint outing with RG 121 from the Dayton area is being held this weekend. Please let her know if you want tickets to attend the observatory on this tour.

Jeep asked Craig to speak about joint outings with the Nifty Fifties club. Craig and a number of other NORG members are also members of the Nifty Fifties. There appears to be a consensus in both clubs that we would like to plan more joint outings, as everyone has enjoyed the ones we have held in the past. This is something that the board of directors should look into.

The November meeting will be one week early. We will meet on November 10 instead of November 17. Please mark your calendars. Also, please bring a generous supply of canned food to donate to the Good Neighbors group for distribution to the needy. The food will be given to the group at the November 10 meeting.

The Christmas Party will be held on December 3 at the Randolph Community Center. Plan to arrive about 1:00 and eat about 3:00.

Casserole Freezing & Thawing Tips

Here's how you can freeze a casserole without giving up the baking dish it's prepared in.

Freezing the Casserole

1. Line an 8-inch square or 13x9-inch baking dish with heavy-duty foil, letting the foil extend over each side by about 5 inches (right).
2. Assemble the casserole as directed in the prepared dish (but do not bake); let cool completely.
3. Cover the top of the casserole with plastic wrap, then fold over the foil edges and seal. Freeze until firm and solid.
4. Remove the frozen wrapped casserole from the dish by flipping it over (right). Place it in a freezer bag and freeze for up to 1 month.



Defrosting the Casserole

1. Remove the wrapping and return the frozen casserole to the dish. Cover and let thaw in the refrigerator for 1 1/2 days.
2. Bake the thawed casserole as directed.
