



Early Ford V-8 Club National Board of Directors Quarterly Meeting Summary

The following is a summary of the subject meeting and should provide each of the Central Regional Groups with an up-date on this important EFV-8 Club business:

Dan Wittern, the Club's Business Manager, reported that overall sales of technical books and accessories were down for the Quarter. However, sales to date of the new 1952-'53 Ford book were currently around \$4,000.

Progress reports were also presented by the various Book Liaisons for the new technical books now in progress; "New" 1940 Ford Book - Bounds / reported progress is currently slow, 1949-51 Mercury Book - Mraz / Engine changes are finished and this new book is expected to be finalized by the end of next year, 1952-53 Ford book has been published and copies became available this past March 2013, Flathead Engine Book - Singletery this new book is in the beginning stages, Proposal to Reprint an existing, 1940-41 Ford Pick-up book / this would be a possible reprinting by the EFV-8 of an existing book that was previously published several years ago by another author.

A Club's 50TH Anniversary Book is also in progress, and should be available this October 2013. Steve Lemmons needs additional early Club historical material, especially from the Eastern and Central regions; photos, etc.

2013 Grand National Meet begins June 17TH at South Lake Tahoe, and has 626 registrations to date with a total expected of over 1100.

National Meets for 2014 are being planned as follows; **Eastern Meet** / June 23-26 at Gettysburg, PA RG #36; **Central Meet**—RG #8 / August 19-22, Springfield, IL; **Western Meet** - RG #84 / Sept. 2-5, Thousand Oaks, CA.

Foreign Regional Group issues were discussed. One of the International groups requested that future meeting agendas include a "line item" for any future International issues. The board agreed to make this agenda addition.

Canadian V-8 Times issues were also discussed relative to the cost of the V-8 Times for Canadian users. It was noted by Dan Wittern that a cost adjustment had been explored previously, but the cost issue appears to be the Canadian Post Office cost structure. Input and alternative ideas will be solicited to determine if improvements can be achieved.

Remaining Quarterly phone conference meetings are scheduled; 3rd Quarter - Saturday August 17, 2013, 4th Quarter - Saturday November 16, 2013.

The **2014 Face-to-Face Board of Directors Meeting** is scheduled for February 18-19, 2014 in Orlando, FL. RG # 152, "Birthplace of Speed" group have been contacted and may assist the Board during this meeting.


AAA cautions motorists about the risks of E15 Available only in a handful of locations — for now

A recent survey by AAA finds a strong likelihood of consumer confusion and the potential for voided warranties and vehicle damage as a result of the Environmental Protection Agency's (EPA) recent approval of E15 gasoline.

More than 95 percent of the gasoline sold in the United States contains up to 10 percent ethanol. Despite objections by auto manufacturers, the EPA officially approved the sale of E15, which contains 15 percent ethanol, last June after receiving a waiver request from producers interested in expanding the use of corn-based ethanol.

Currently, E15 is available only in the states of Nebraska, Iowa and Kansas. If and when it does become more widely available, fuel pumps will be clearly marked with black and orange labels to differentiate E15 from more familiar formulations.

Unsuspecting consumers using E15 could end up with engine problems that might not be covered by their vehicle's warranty. Five manufacturers (BMW, Chrysler, Nissan, Toyota and Volkswagen) are on record saying their warranties will not cover fuel-related claims caused by the use of E15. Seven additional automakers (Ford, Honda, Hyundai, Kia, Mazda, Mercedes-Benz and Volvo) have said that E15 does not comply with the fuel requirements specified in their owner's manuals and may void warranty coverage.



"It is clear that millions of Americans are unfamiliar with E15, which means there is a strong possibility that many motorists may improperly fill up using this gasoline and damage their vehicle," said John Nielsen, AAA's Director of Automotive Engineering and Repair.

With less than five percent of cars on the road approved by automakers to use the fuel, AAA is urging regulators and the industry to stop the sale of E15 until motorists are better protected. AAA automotive engineering experts believe that sustained use of E15 could result in significant problems, such as accelerated engine wear and failure, fuel-system damage and false "check engine" lights for any

vehicle not approved by its manufacturer to use E15.

The only vehicles currently approved by automakers to use E15 are flex-fuel models, 2001 model-year and newer Porsches, 2012 model-year and newer GM vehicles and 2013 model-year Ford vehicles. The use of E15 is expressly prohibited in heavy-duty vehicles, boats, motorcycles, power equipment, lawn mowers and off-road vehicles.

"The sale and use of E15 should be suspended until consumer education efforts are implemented to mitigate problems for motorists and their vehicles," said Brian Newbacher, director of public affairs for AAA East Central. "Consumers should read pump labels carefully and know their auto manufacturer's recommendations to help prevent any E15 related problems."

AAA urges fuel producers and regulators to do a better job of educating consumers about potential dangers before selling E15 gasoline. This outreach should include a consumer education campaign and more effective pump labels, among other safeguards.

STUDY CONFIRMS PROBLEMS

New research released by the Coordinating Research Council (CRC) last January, found that E15, gasoline blended with 15 percent ethanol, would damage millions of post-2001 model year vehicles. The CRC — which is supported by Chrysler, Ford, General Motors, Honda, Mitsubishi, Nissan, Toyota, and

Toffee-Topped Bars

 **15 minutes preparation, 35 minutes baking**

Makes 24 brownies

- 2 cups firmly packed brown sugar
- 2 cups all-purpose flour
- ½ cup (1 stick) butter or margarine, softened
- 1 teaspoon baking powder
- ½ teaspoon salt
- 1 teaspoon vanilla extract
- 1 cup milk
- 1 egg
- 1 cup semi-sweet chocolate chips
- ½ cup chopped walnuts
- ¼ cup unsweetened flaked coconut (optional)

1 Preheat oven to 350°F. Lightly grease a 13 x 9-inch baking pan; set aside.

2 In a large mixing bowl, mix together the brown sugar and flour.

3 Using a pastry cutter or two knives, cut in the butter until mixture resembles coarse crumbs. Remove 1 cup of mixture and set aside.

4 To mixture in large bowl, add baking powder and salt. Using a fork, lightly beat in vanilla, milk and egg.

5 Continue beating until a smooth batter forms. Pour batter into prepared baking pan.

6 In a small bowl, combine the chocolate chips and walnuts. Fold in the coconut.

7 Sprinkle reserved crumb mixture over top of batter in pan. Sprinkle with the chocolate chips and walnuts.

8 Using a long flat spatula,



spread topping evenly over the top of the batter in pan.

9 Bake bars for 35 minutes, or until a skewer inserted in center comes out clean.

10 Transfer pan to a wire rack. Cool bars in pan completely before slicing.

11 Using a serrated knife, cut into 24 bars. Store in airtight container for up to 5 days.

Baking Tips

Measuring ingredients accurately is one of the essential elements for successful baking. When measuring brown sugar, spoon the sugar into a measuring cup, then press down firmly with the back of the spoon to expel all air pockets. Level off the top with the flat edge of a spatula or knife.

Fresh Berry Crumb Pie

A hazelnut mixture does double duty as a crust and topping in this berry-filled pie.

 **45 minutes preparation, 30 minutes baking**

Makes 6 servings

Crumb Crust/Topping

- 1 cup hazelnuts or almonds (about 4 ounces)
- 2 cups all-purpose flour
- $\frac{1}{2}$ cup granulated sugar
- $\frac{3}{4}$ cup ($1\frac{1}{2}$ sticks) chilled butter, cut into small pieces

Filling

- $\frac{1}{2}$ cup granulated sugar
- $1\frac{1}{2}$ tablespoons cornstarch
- 2 pints fresh berries (such as blueberries, raspberries, and/or strawberries)

1 Preheat the oven to 350° F. To prepare crumb crust/topping, spread nuts in a medium baking

pan. Roast the nuts, stirring occasionally, until toasted, about 10 minutes.

2 Remove nuts from the oven and turn out onto a cloth towel. Rub off and discard the papery skins. Increase the oven temperature to 450° F.

3 In a food processor fitted with the metal blade, process the nuts until finely ground, about 10 seconds.

4 In a large bowl, mix together the nuts, flour, and sugar. Using a pastry blender or 2 knives, cut the butter into the flour mixture until coarse crumbs form.

5 Using fingers, evenly press half of the crumb crust/topping mixture into the bottom and sides of an 8- or 9-inch tart pan.

6 To prepare the filling, in a medium bowl, mix together the sugar and the cornstarch. Gently fold in the berries. Spoon the berry mixture into the crust, spreading evenly.

7 Sprinkle the berry mixture evenly with the remaining crumb crust/topping.

8 Bake until topping is golden and filling is bubbly, 30 minutes. Transfer the pan to a wire rack to cool for 10 minutes. Serve warm.

Baking Tips

Watch nuts very carefully when you are grinding them in the food processor. If you grind them too long, the result will be nut butter.
